ABOUT THE FACILITY

Arenas & Footing

Indoor competition arena, dirt improved with sand and sawdust. Covered warm-up arena, dirt footing. Intro-Training Level Test 2 ridden in 20m x 40m short arena; all other tests ridden in 20m x 60m standard arena.

Children and Pets

Yamhill County Fairgrounds allows leashed dogs on grounds. Small children must be under the control of a parent or guardian.

Food

Concessions on grounds.

RV Hookups/Camping

Hookups are \$15/day, please make reservations and pay in full with entry.

Stabling

Horse or Tack Stall box stall with full doors and initial bedding (shavings)

Prize to first place for classes of 3 or more; ribbons through fifth place.
