Minutes of the March 13, 1983 meeting read by secretary, Winnie Heiney and approved.

Treasurer's report by Dagmar Fancier. Balance ending 6/30/83 \$2,064.00. She suggested a business like approach for 1984 with all officers having some allotment in the budget. The August meeting, was the date set for officers to estimate expenses.

Membership report by Joyce Heinke. Ninety Six new members this year. Total-291- mailing list, (263 Sr. members-60 Jr. members.) She read a letter from a Jr. member concerning dues not received by ODS until after competition. The rule cited was, "unless dues are received prior to competition no points will be awarded." Your ODS Membership card should be in the mail to you soon after your dues are received. If you do not receive your card, in time for your first competition, get in touch with the membership chairman.

ODS members have been omitted from the new USDF list. Social Security #s are now being used for most members. The USDF membership year (April 1- March 31), the USDF awards year (Sept. 1- Aug. 31). A motion by Wendy Lowe, seconded by J. Heinke: "New members will pay \$2.00 additional per membership toward USDF Award coverage thru March 31.

Show Dates - Due to conflicting dates, a discussion voicing several viewpoints followed. Oregon Dressage Society Chapter Shows as a whole should certainly be supported, suggested B. Tuohino Funk. Dagmar Fancher promoted Non-Chapter Shows as generally less effort for hard working Chapters. A need to arrive at dates early and participate in the August yearly session of ODS Planning Meeting is imperative for both Chapters and Non-Chapters to help avoid conflicts. (W. Heiney)

The motion made to approve only one USDF, AHSA Show per weekend was seconded by Dagmar Fancher and voted positive by the members present.

These rules were presented:

- (1) One Show per weekend would be granted ODS Approval. (AHSA, USDF)
- (2) Mary Cornelius would be in charge of approvals granted by ODS.
- (3) Schooling shows should be coordinated in areas and cleared by Mary Cornelius.
- (4) ODS Membership should appear in the prize list and the program of the approved shows. (Regular Membership Form)
- (5) Every effort should be made to attend the August planning Session by both Chapter and Non-Chapter Shows. Those not able to attend should submit their dates in writing to M. Cornelius for presentation at the planning meeting.
- (6) A certificate would be mailed to each Approved Show indicating ODS approval. (M. Cornelius)
- (7) Applications for Show approval should be submitted <u>90 days</u> prior to <u>SHOW DATE</u> (M. Cornelius)

Every effort to coordinate Dressage activities with all outside and Chapter groups, by working together and planning with a knowledge of other activities being planned, it is our hope that scheduling conflicts can be avoided. Winnie Heiney was appointed to draft a letter to those listed in In Stride- Calendar- asking them to respond with their 1984 dates.

Linda Buttolph presented a tentative class list for the Championship Show. The list was revised. D. Fancher motioned to accept the revision. Pat Drew seconded and the motion passed. B. Funk Tuohino suggested in addition to ads, the sponsor be given special seating. ie- ribboned area, complimentary cocktails tickets, special ribbons or certificates stating they had sponsored the Championship Show.

Betty Brown offered to take care of the missing dressage fences.
