## Prize List/Entry Form:

- ◆ Plan ahead: prize list/entry form must be on file with the ODS at least 6 weeks prior to entry opening date
- ◆ All prize lists must be updated to contain the ODS show approval number and current year ODS Membership Form.
- ◆ Prize lists must state where official document will be obtained – i.e. if the official document is to be obtained from the ODS website, then we will upload it to our site. If the official document is to be obtained from another website, then we will link it to our site.
- ◆ Licensed competitions: please follow USEF/USDF guidance for prize lists. The prize lists must contain the ODS Championships Qualifications and ODS Awards page. Prize lists/entry forms will be reviewed by the ODS Office.
- ◆ League competitions: prize list must include the ODS League Show Standards, the ODS League Finals Qualifications and the ODS Awards page. Prize lists/entry forms will be reviewed by the ODS Office.  
League Shows must also have a space for the ODS *Participation Fee* (\$1/ride)

- ◆ All entry forms must have a space for the USDF Member Number.

## Insurance:

*ODS Sponsored* (includes ODS Committees and ODS Chapters)—must fill out separate insurance application.

*Non ODS Sponsored*—It is required that all shows provide a copy of your certificate of liability insurance, naming **The Oregon Dressage Society, Inc., its Agents, Officers and Directors** as additional insured, at least 6 weeks prior to the entry opening date of show.
