Equine Vaccination Requirements

According to [USEF GR844](#), At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables.

1. **All horses are required to provide proof of vaccinations no later than 5:00pm on Wednesday before the show.** If we do not received your vaccination records, you will not be allowed on the grounds, and we will not refund your entry or any associated fees.
2. Negative EIA/Coggins within 12mo is required for all out of state entries.
3. Health Certificates are required for all out-of-state competitors.

 - Champion and Reserve Champion will be awarded for each show separately from the NDPC Pony only classes.
 - To be eligible to compete in the NDPC Pony Only classes a USEF Measurement card must be on file with the USEF.
 - NDPC Year-End Awards: All tests and freestyles ridden in Pony classes will automatically be entered in NDPC Year End Awards.

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF INHERENT RISKS: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with equine activities, including but not limited to horseback riding and equestrian sport, are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

EQUINE ACTIVITY LIABILITY ACT WARNING:

I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT UNITED STATES EQUESTRIAN FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

1. **ADDITIONAL SHOW PERSONNEL:** Veterinarian and Farrier will be on call; names and contact information will be posted at the Show Office. First Aid available from EMT/Medical Personnel on grounds during competition hours.
2. **ENTRIES:** Observe opening and closing dates published on the title page. Entries received before opening date will be penalized. Telephone or email entries will not be accepted. Entries will be accepted on a first-come, first-served basis until available ride times are filled. Subsequent entries will be wait listed. All entries received by closing date will be confirmed via e-mail. Please contact the Show Secretary if you have not received a confirmation email by one week after closing date. No entry will be accepted without payment of fees, either by check or credit card on **Horse Show Office (<https://horseshowoffice.com/#/events>)**. All information and signatures must be clearly legible. All competitors, by completing their entry, acknowledge and attest that they have read and understood all terms of these rules, wherever listed in this prize list. Management may deny entry to any competitor if the competitor has outstanding debt to the sponsoring organization.
3. **USEF SHOW PASS:** Riders and Owners are now only eligible for one (1) Show Pass (or non member fee) per year. This fee must be purchased online from USEF. The Show Pass is only good for one competition. Trainers and Coaches are no longer eligible to be non members or use a Show Pass. Trainers and Coaches must be members and this includes parents that sign as trainers and coaches.
4. **ONLINE ENTRIES:** **Online show entries through Horse Show Office are encouraged.** Payment can be made via credit card or check. Payment may also be mailed to Lake Oswego Hunt **c/o Jeannette Parrett, 31012 20th Ave S, Federal Way WA 98003. Include printed entry from Horse Show Office with check. There is a 4.5% processing fee for paying via credit card online. There is no added charge for paying by check online. All signature pages must be printed, signed, scanned, and uploaded to each online entry.**
5. **SAFE SPORT: Reminder:** All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.
6. **WAITLIST ENTRIES:** A waiting list will be established once all ride times have been filled. Those who choose to remain on the waiting list but do not get into the show will have their entry check destroyed (not cashed) and no fees will be assessed. Online payments will be refunded via PayPal, minus the PayPal service fee.
7. **INCOMPLETE OR INACCURATE ENTRIES:** Proof of registrations and memberships must be provided with each entry. All signatures must be present. Competitors will be assessed a fee of \$20 for missing signatures or information. Bridle numbers will not be awarded at show until all fees are paid.
8. **POST ENTRIES:** Management reserves the right to accept post entries if space allows or in case of cancellation. Post entry fee: \$20 per entry (horse/rider combination). Online entries will close at midnight on entry closing date. Post entries must be submitted and paid through **Horse Show Office**. No mail-in post entries will be accepted.
9. **REFUNDS:** A) 100% (except for the \$50 Cancellation Fee) before the show's closing date. B) After the closing date and upon presentation of a Veterinarian or Doctor's certificate, there will be a refund of 50% of the class fees, 100% of the USEF drug fee, 100% of any USDF qualifying fees, and stall fees. The Veterinarian or Doctor's certificate must be received before noon of the Monday before the competition to be considered for the refunds listed in section B of this rule. There will be no refund of the Office fee. No refunds of any type will be made if notice of cancellation is received later than the deadline of the Monday before the competition. No refunds will be made if the entry is a no-show. Lake Oswego Hunt reserves the right to cancel, without refunds to the riders, all or part of the competition including individual classes, due to a storm, acts of God, accident or other emergency. Qualifying fees for rides scratched at the show will be refunded, if picked up in person at the show office. Qualifying refunds will NOT be mailed or processed through PayPal in this case.
10. **DRUGS AND MEDICATIONS:** A \$25 Federation fee, of which \$15 is the USEF Equine Drugs and Medications fee, will be assessed per horse, per show. Opportunity classes are exempt from this fee.
11. **FEES:** Please see Show Fees list for all current fees.
12. **RIDE TIMES:** **Tentative ride times will be posted online no later than 5 days before the competition with notice emailed to all riders.** It is the responsibility of the rider to inform the show secretary of any time conflicts as soon as possible after the tentative schedule is

posted. The **official and final ride times will be posted in the Show Office**. Ride times will not be mailed; it is the responsibility of the exhibitor to obtain his/her ride times from competition management or from posted sources.

13. **COMBINATION/CANCELLATION OF CLASSES:** Show Management reserves the right to combine or cancel classes where fewer than three (3) horses are entered or limit the size of a class as necessary. Show Management also reserves the right to change the order of the classes as they are listed in the Prize List. Competitors in changed classes will be notified per USEF GR 830. Classes cancelled because of weather may be rescheduled or remain cancelled. NO REFUNDS.
14. **TEST OF CHOICE (TOC) CLASSES:** A horse may compete only once in any class including Test of Choice. There will be no changes in your Test of Choice selected after the entry form is processed, except with payment of \$10 Entry Change Fee. If no test choice is specified on the entry form, management will assign the highest test of the level.
15. **QUALIFYING/NON-QUALIFYING CLASSES:** At each level, the highest test of that level may be designated a Qualifying ("Q") class for the 2026 Great American Insurance Group/USDF Regional Championships. Eligibility requirements for Q classes: **Rider** must be USDF Participating Member and USEF Life or active member. **Owner** (if multiple Owners, only one Owner) must be: a) USDF Participating or Business Member, b) an Active Member of USEF and c) must be the owner of record with USDF and USEF. **Horse** must have current annual or lifetime recording with USEF; USEF Horse ID is not sufficient. Horse must be USDF lifetime registered; USDF Horse ID is not sufficient. \$20 qualifying fee. Qualifying fees for rides scratched at the show will be refunded or reapplied to cover indebtedness to the competition by the competitor. Refunded fees MUST be picked up in person at the show office. Qualifying refunds will NOT be mailed in this case. See [USDF.org](https://www.usdf.org) for additional details.
16. **OPPORTUNITY CLASS:** Opportunity classes are intended for entry level participants. Horses, riders, owners, trainers, and coaches participating only in Opportunity classes are exempt from Federation and affiliate organization membership and Horse Identification (HID) requirements and non-member/Show Pass fees. Riders are required to list the Federation membership number if the participant is a member. Horses entered in Opportunity classes are subject to and must comply with all Drugs & Medications rules, including vaccinations, and are subject to testing but are exempt from the Federation fee. Opportunity class riders may compete wearing breeches and shirts of any color as permitted in DR120. Jackets or vests of any type are allowed but not required and neckwear may be worn only if the rider chooses to compete in a riding jacket. Boots and protective headgear are required as specified in DR120.1.6. Scores earned in Dressage Opportunity classes may not be used towards USEF or USDF awards or programs. See USEF GR821 for complete rules. **Cross-entry between Opportunity and other classes is allowed; however, the above exemptions only apply to Opportunity Classes.**
17. **MUSICAL FREESTYLES/ SOUND CHECKS:** **ONLY CDs are acceptable. The musical selection for the freestyle must be specified clearly on the CD itself. Two CDs with protective covers must be brought to the sound check 'engineer' at the designated time and location. Sound checks will be held from 5:00pm-6:00pm on Friday of the competition weekend.** It is the responsibility of the riders to pick up their music after the Freestyle class at the sound station or the Awards desk. Management will not be responsible for music left after the closing of the show. In order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth levels and 60% for FEI levels in the highest test of the declared freestyle level or any test of a higher level at a USEF/USDF licensed Dressage Competition, Federation Licensed or FEI recognized Dressage Competition, or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility must be submitted with the entry for a freestyle class. Specify level of freestyle on your entry.
18. **SCHOOLING ENTRIES:** Horses brought onto the grounds but not entered in the show must be registered with the Show Office and will be given a number to be worn at all times outside of the stall. Schooling-only entries are subject to the same rules as competing horses with additional restrictions on the times and general use of any facility amenities. Any person(s) riding a schooling horse must have signed an official entry blank and/or release form. Appropriate stall fees and schooling fee per show must be paid in addition to the Office fee for each show. Horses entered as schooling-only but later converted to class entries must pay all additional fees as required for entry.
19. **NO SHOWS (or Scratches):** All "No Shows" that have not checked in with the show office a minimum of 45 minutes prior to their first ride and picked up their exhibitor numbers will be considered a "scratch" for the rest of the show and their ride time slots may be filled. There are no refunds for scratched entries or classes. Also, scratches by competitors on the show grounds are official ONLY when made to the Show Secretary. Scratches made to warm-up or ring stewards are not official and may be considered NO SHOWS. If the competitor cannot come to the show office to scratch in person, they may send a representative.
20. **ARENAS:** All tests are ridden in 20 x 60 meter indoor arena with GGT footing or 20 x 60 meter outdoor arena with sand footing. Warmup areas include a grass field, wood product track and a 20 x 60 meter outdoor arena with sand footing. Arenas close at 8:00 pm. **Lunging permitted in designated, marked areas.**

21. STABLING: All Stalls are Chinook portable 10' x 10' with either canvas or solid walls and full doors. One bag of shavings is provided with each stall. Additional bags may be purchased. Stall charts will be posted online and check-in will start at 2:00 PM on Friday prior to show. Stalls may not be resold or sublet by an exhibitor.
22. STALL BEDDING: First bedding is provided. Additional bedding can be purchased at show office. Cost for additional bedding is \$14 per bag; fill out requests at the Show Office. Bedding orders must be placed by 9 am to be received the same day. All stalls need to be stripped prior to departure from the facility. Those not adequately cleaned will incur \$25 cleaning fee.
23. ARRIVALS and DEPARTURES: Early arrivals & late dismissals are possible only by direct arrangement with Lake Oswego Hunt. **Stalls will be available after 2:00pm** the day prior to the first day of competition. Arenas will be available for schooling after 3:00pm.
24. SHOW OFFICE HOURS: **Open one (1) hour prior to the first ride each day and will close one-half hour after the last class of the day. The day before the competition starts, the office will be open 2PM - 7PM.**
25. CONCESSIONS: are available at show grounds during show hours.
26. DOGS: Per USEF Rule GR1301.6: Dogs are not permitted to be loose on competition grounds and must be held on a leash or otherwise restrained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses, or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule will be issued a Yellow warning card and may be subject to penalty under [USEF General Rules] Chapter 7. All dogs must be registered with the Show Office and pay \$30 dog fee. **NO DOGS ARE ALLOWED BY THE COMPETITION OR WARM UP ARENAS AT ANY TIME.** Leave them at home or in the stabling area.
27. NO SMOKING: Lake Oswego Hunt is a smoke free facility. No smoking anywhere on the grounds or inside the facility.
28. CAMPING: No hookups are available for camping. Fires and generators are prohibited.
29. LOCAL ACCOMMODATIONS: Make reservations early: Best Western Lake Oswego, 14905 SW Bangy Road, Lake Oswego, OR 97035, (503) 624-7400, https://www.bestwestern.com/en_US/book/hotels-in-lake-oswego/best-western-lake-oswego-portland-hotel-suites/propertyCode.38185.html. Ask for the LOH rate for the show weekend.
30. DRIVING DIRECTIONS: **From the north**: I-5 south to Hwy 217 exit (#292); left onto Kruse Way to end. Right onto Boones Ferry Rd. Left onto Reese Rd; left onto Upper Drive. Lake Oswego Hunt Club is on the left, just past the traffic circle. **From the south**: I-5 to Lake Oswego Exit (#290). Right onto Boones Ferry Rd; right onto Reese Rd; left onto Upper Drive. Lake Oswego Hunt Club is on the left, just past the traffic circle.
31. AWARDS: Prizes to 1st place and ribbons 1st- 5th place. An award will be provided to the highest score (excluding Intro, Equitation, Freestyles, Opportunity classes, and Materiale scores) for each National division (Junior/Young Rider, Adult Amateur, and Open) and for highest score FEI all divisions combined for each competition.
32. HELMETS: From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on any competition or schooling entry must wear protective headgear, defined as a riding helmet which meets or exceeds ASTM/SEI standards for equestrian use and carries the SEI tag. The harness must be secured and the helmet properly fitted. In addition, Effective 12/01/2015 as per USEF DR 206.6, **ALL Handlers, Assistant Handlers and Whip Assistants** are required to wear protective headgear, defined as a riding helmet which meets or exceeds ASTM/SEI standards for equestrian use and carries the SEI tag, with the harness properly fitted and secure when in the competition ring.
33. DRESS CODE: Management may announce prior to or during a competition that competitors can show without jackets due to extreme heat and/or humidity. If jackets are waived, competitors must wear a shirt with sleeves and collar, without neckwear. Eliminations are mandatory for all dress code violations as specified in USEF rules.
34. SHARPS CONTAINERS: Approved sharps containers can be found on the show grounds. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.
35. PONY MEASUREMENT: Any request for an official pony measurement must be made in writing at least five days prior to the start of the competition weekend. Pony measurements, with veterinarian and TD present, will be held the evening before the show begins at 5:30pm. There will be a charge of \$100 per measurement held. **Please email Jeannette Parrett (horseshowjet@hotmail.com) to schedule measurement.**
36. NATIONAL DRESSAGE PONY CUP PARTNER SHOW CLASSES: Ponies must meet USEF/USDF height requirements, DR 135.1 and have a valid USEF measurement card or be measured at the show (See Rule 35). Ribbons awarded for each of the classes. NDPC Year-End Awards: Ponies that are not members are not eligible for NDPC Year-End Award prizes. If riders would like their scores to be eligible to

compete for NDPC Year-End awards, competitors must be current members of the National Dressage Pony Cup by October 31st. Learn more at www.dressageponycup.com.

37. **RELEASE OF RESPONSIBILITY:** USEF, USDF, Lake Oswego Hunt, Show Officials, Show Management, and/or employees and volunteers will not be responsible for any accident and/or loss that may occur to any person, exhibitor or his agent horse and/or equipment. Horses, by their inherent nature present a risk of injury, harm or death. Riders represent that they are qualified to participate at the level entered. Each exhibitor is responsible for any injury or harm, that may be occasioned to any person, whomsoever, by any horse owned or exhibited by said exhibitor, and shall hold harmless and indemnify any agencies or persons listed above, against all claims or demands, of any nature or kind, that may grow out of any injury occasioned by any horses owned or exhibited by them, or arise from the negligence of the person in charge of such horse. All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. All horses exhibited at these shows participate entirely at the owner's or rider's risk.
38. **SPECIAL RELEASE:** By signing the entry agreement, I further agree to: "release, indemnify and hold harmless USDF, its instructors, officers, directors, agents, and volunteers from and against any and all loss, liability or damage arising from or because of, or in connection with, participation in this competition or related activities. I also hereby agree to release, indemnify and hold harmless the show management, show committee and members, officers, directors, agents, and volunteers from and against any and all loss, liability or damage arising from or because of, or in connection with, participation in this competition or related activities."
39. **VACCINATION RULE:** (See USEF GR844 for details) Exhibitors are reminded of USEF's vaccination policy: At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the competition venue. Negative EIA/Coggins within 12mo and Health Certificate is required for all out of state entries. All horses are required to provide proof of vaccinations no later than 5:00pm on Wednesday before the show. Non-compliant entries may be quarantined or denied permission to unload and will not be allowed to compete nor to mingle with other horses. No refunds will be given if right to compete is denied because the Vaccination Record is missing or incomplete. *Whether the horse is vaccinated by a veterinarian, or by an owner or agent, documentation is required.* For your convenience a downloadable form is available at: www.usef.org. Search 'Equine Vaccination Record'.
40. **INTERSTATE TRAVEL:** Exhibitors are reminded that State entry requirements apply to horses entering Oregon and returning to the state of origin or elsewhere. These requirements vary from state to state. Always confirm state requirements for equine travel to and from OR. "Interstate Livestock" may be helpful: <https://www.interstatelivestock.com>.

USEF Biosecurity Requirements

Effective 12/1/24

The competition grounds can pose significant risk for disease exposure to your horse. However, you can protect your horse by taking the following biosecurity measures to reduce the risks while on the event grounds:

- **Limit horse-to-horse contact:** Increase distance between your horse and other horses in the warm-up or competition arena or at the wash rack or other commingling areas to limit potential for disease pathogen exposure. Ensure the stall door is closed to prevent direct contact with other horses in the aisles.
- **Limit horse-to-human-to-horse contact:** Decrease or limit the number of people interacting with your horse. Ideally, those persons in direct contact with your horse should have no contact with other horses on the event grounds. If they have had contact with other horses, they should wash hands, change clothes and footwear and clean and disinfect any shared equipment prior to entering your horse's stall.
- **Avoid sharing equipment or supplies:** Any equipment or supplies which have had direct or indirect contact with other horses should not be shared with your horse or brought into your stabling area. If the supplies or equipment must be shared, it is to be thoroughly clean and disinfect between uses. Nose rags should never be shared between horses. Cover feed and hay to reduce the risk of contamination.
- **Designate Supplies for Each Horse:** A water bucket, feed bucket, brushes and tack should be designated, labeled with horse name and restricted to use for that horse. If shared, they must be thoroughly cleaned and disinfected.
- **Prevent submersion of hose into water buckets:** When watering your horse do not submerge hose in the water bucket, as hose may have been contaminated when providing water to another horse.

Competitor Requirements (GR870)

All riders, drivers, vaulters, handlers, owners, trainers, coaches, grooms, agents, and lessors must abide by and comply with biosecurity measures and equine health requirements imposed by the Federation, Competition Management, and local, state, and federal animal health officials.

Competition Management Requirements (GR871)

Competition Management must ensure licensed competitions are conducted in accordance with all applicable Federation, local, state, and federal animal health requirements.

Mandatory Reporting of Febrile Horses (GR873)

The trainer, as defined by Federation rules, or the owner if the trainer is unavailable, or the rider if the trainer and owner are both unavailable, shall notify the competition veterinarian and Competition Management as soon as possible but no later than two hours after detection of any febrile horse or pony. A febrile horse or pony is one with an unexplained temperature above 101.5°F at rest (i.e. two hours after exercise or transport). If a febrile horse or pony is detected outside of competition hours or before the competition begins, notification must occur as soon as possible but no later than one hour detection of the fever above 101.5°F.

Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8th Place and gift certificates awarded to top four riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- or*
- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

As those engaged in equestrian sport, we are committed to ensuring our horses receive the best possible care to the best of our ability. We acknowledge that we are the caretakers of our horses and as such we are committed to always, without exception, treating our horses with dignity, fairness, kindness, and understanding.

We realize that horses, whether in a herd or as an individual, will communicate contentment, fear, pain and confusion in the only way they can, which often takes the form of physical reactions that can be misinterpreted and misunderstood.

Therefore, we believe it is our obligation to seek to understand our horses with the goal of providing care and training methods that are never the manifestation of anger, frustration or cruelty. We are committed to these principles at all times, whether on or off the show grounds.

We are committed to humane treatment and application of these principles on behalf of all animals including but not limited to horses, donkeys, mules, companion animals, and pets. Lack of humane treatment, whether the result of actions taken, or by care withheld, will not be tolerated.

USDF Membership Benefits: USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the USDF Member Guide or the USDF website at www.usdf.org.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

USEF MOTORIZED VEHICLE STATEMENT

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. **The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation.** Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds.

Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

USEF POLICY ON SHARPS DISPOSAL (GR1210.4)

Competition management shall place a minimum of one sharps container per each competition, whether or not stabling is provided. Additionally, at least one sharps container per fifty occupied stalls for the disposal of needles and other disposable sharp instruments in convenient locations in barns housing competition horses. It is competition management's responsibility to replace such containers when full and dispose of them properly. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Competition management will place a notice of this requirement either in its prize list or on a specific handout given to trainers on check in at the competition. If local law has different requirements, local law will prevail. Competitions failing to comply with placing the required number of containers on the show grounds will be considered in violation of the rules and may be subject to penalty as determined by the CEO or his designee and/or the Hearing Committee.



2026 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2026 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).

A horse is not required to have breed registry papers.

- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual Recorded Farm/Business (with Senior Active Competing Farm Owner in good standing)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider.

ODS LICENSED CHAMPIONSHIP QUALIFICATION

ODS has offered an annual Championship Show since 1981. This show is traditionally the largest annual fundraiser for our organization and is a showcase of the best ODS horses and riders. You may qualify! Please join us for this wonderful event.

QUALIFYING RULES

General:

- Rider must be a **CURRENT ODS MEMBER** in good standing **AT TIME SCORES ARE EARNED**
- Each horse entered must be ridden by the same rider throughout the competition
- Additionally, at no time during the Championship competition may an entered horse be ridden by anyone other than the rider entered on that horse (with the exception of a groom walking on a loose rein)
- Attach photocopies of the front cover of the qualifying tests to the entry form

Qualifying:

- **The qualifying season is September 1st of the previous year to August 25th of the current year**
- Qualifying scores must be earned by a **horse/rider combination**, they cannot be earned separately
- Only scores received at USEF/USDF Licensed shows may be used
- Only scores received using current USDF / USEF / FEI approved dressage tests count
- Championship scores will be calculated by averaging the percentages earned in the two tests ridden
- Scores from the following dressage tests do not count for the ODS Championship Show:
 - Dressage equitation
 - Dressage suitability
 - Rider tests
 - USDF Introductory Level
 - Opportunity classes
 - Lead line classes
 - Scores earned at ODS approved league shows and practice shows

Championship Classes:

- Classes will be run under USEF/USDF Championship Rules
- Championship classes **must be ridden from memory**
- Whips are **not** allowed
- We will not be closing competition arena gates during tests, nor raking centerlines between riders.

Tests:

- Tests selected for championship classes are at the discretion of show management
- Training–Fourth Levels will ride the two highest tests of the level
- FEI Championship classes will be judged by two judges
- Horse/rider combinations may enter two levels, but may only ride in one division (Open, Adult Amateur, or Junior/Young Rider)
- Horse/rider combinations winning Championship Show classes may not compete at that level in future championship classes (except FEI)

Minimum Qualifying Scores:

- Entries must have earned two qualifying scores; per level, per division, and from two different judges at two separate competitions
- Qualifying scores may be earned at any test from the level
- The minimum percentages are as follows:
